

PRESIDENT'S MESSAGE

MANUFACTURERS NEED TO ENGAGE IN OUR ENERGY FUTURE



The New York State Department of Environmental Conservation (DEC) and New York State Energy Research and Development Authority (NYSERDA) have begun a series of stakeholder information sessions and will

develop a New York State economy-wide Cap-and-Invest Program.

The Cap-and-Invest program was recommended by the Climate Action Council's final Scoping Plan and was proposed in Governor Kathy Hochul's 2023 State of the State Address and Executive Budget. DEC and NYSERDA are developing this program to meet the greenhouse gas emission reduction and equity requirements under the 2019 Climate Leadership and Community Protection Act. (the Climate Act).

The first phase included pre-proposal webinars held throughout June. These webinars provided an overview of New York's potential program, and similar programs, designed to reduce greenhouse gas emissions in other states and jurisdictions. They also provided an opportunity for key stakeholders and the public to offer feedback on program design features. All stakeholder input will be considered by staff as part of the program development.

Future efforts related to the Cap-and-Invest Program will focus on obtaining input regarding anticipated program design details, such as applicability and thresholds, allowance allocation and auction, stability mechanisms, compliance and enforcement, and reporting and verification. A second round of stakeholder outreach is expected to be held later this year. More information on the Cap-and-Invest Program is available at: capandinvest.ny.gov.

Now is the time to get involved. I highly recommend all members become familiar with the elements being discussed and offer their comments and insights regarding the Cap-and-Invest program. We ask you to join us in influencing its development. Your energy future will be greatly impacted by the program.

Energy is the lifeblood of manufacturing. Its availability, affordability, accessibility, and reliability are critical to every manufacturer in New York State. MACNY and our members need to be engaged at every stage of the development and implementation of the Climate Act.

MACNY is assembling a cohort of member companies who will be reviewing the impacts of the Climate Act and related efforts such as the Cap-and-Invest Program. ALBANY WORKS SIMULTANEOUSLY ON LEGISLATIVE SESSION AND REGULATORY PROCESS

The New York State Legislature experienced the usual flurry of activity in June seeking to conclude the 2023 State Legislative Session. MACNY, led by advocacy efforts from membership, and with assistance from Albanybased Ostroff Associates, tracked and weighed in

on a broad range of legislation that would impact manufacturers in the areas of economic development, energy, the environment, tax, and workforce. As previously reported, the 2023-24 New York State Final Budget enacted in May included two major highlights for manufacturers:

- The New York State Majority again fully funded at \$1.75M to grow the proven and increasingly popular "earn and learn" Registered Apprenticeship program across New York State.
- 2. The Hochul Administration, along with the State Senate and State Assembly, supported an exemption for manufacturing facilities for the all-electric requirements for new construction. These successes were centerpiece issues at Manufacturing Advocacy Day on March 1 in Albany. MACNY will continue to advocate for tax parity for all manufacturers next budget cycle having earned the support of the New York State Assembly Majority only.

Simultaneous to the end of session legislative proceedings in June, the regulatory process was fully engaged with seven stakeholder information sessions for the State's economy-wide Cap-and-Invest Program (NYCI) hosted by the New York State Department of Environmental Conservation (DEC) and New York State Energy and Development Authority (NYSERDA). You will recall that NYCI was recommended by the Climate Action Council's final Scoping Plan and proposed in the Governor's 2023 State of the State Address and Executive Budget.

MACNY monitored these sessions and submitted written comments specific to energy-intensive and trade-exposed (EITE) manufacturers. MACNY and the Manufacturers Alliance of New York will continue to closely monitor and weigh in on the development of regulations on NYCl and all other aspects of the Climate Leadership and Community Protection Act (CLCPA).

MACNY will review each of the several thousands of bills the State Legislature will deliver to the Governor for final consideration before the end of the calendar year and give thoughtful consideration of the impact on manufacturing and issue a letter in support or opposition as appropriate. One bill of concern likely to be delivered to the Governor is S.6636-A (Hoylman-Sigal)/A.6698-A (Weinstein) that would greatly expand legal remedies for a variety of case types that would result in severely increased costs on all New York civil defendants, public and private, who would see costs needlessly increase. Several other bills of concern were stalled in one or both houses through efforts by MACNY, the Manufacturers Alliance of New York, and the New York State business community. Finally, two measures sponsored by members of the Senate and Assembly Majorities that MACNY will watch closely next session and likely support are S.7250 (Cooney)/A.7549 (McDonald) that would sunset COVID sick leave, and S.6030 (Parker)/A.6039 (Barrett) that would return New York's methodology for accounting for greenhouse gas emissions - and emission reductions - to one consistent with those adopted by international, federal, and state-level governments.

As we know, legislative session days do come to an end in Albany, and our elected officials return home to the district. MACNY encourages members to reach out to your local State Senate and Assembly Members inviting them to your place of business to engage in dialogue about owning and operating a business and recruiting, training, and retaining employees in New York State. MACNY will be reaching out to members to host our elected officials and continue the on-going process of building a better understanding of manufacturing that benefits our local communities and Great State of New York.

PERMAFROST: NOT JUST A PERMANENT HAIR DYE

In my opinion, permafrost is interesting and vital to our existence here on Earth. By definition, permafrost is a permanently frozen layer on or under Earth's surface composed of rock, soil, sediments, and ice. It

is found under a layer of soil and can be a few or up to 49,000 feet thick. It may be tens of hundreds of thousands of years old and is estimated to hold 1,500 billion tons of carbon (double that in the atmosphere). Because it is composed of dead/decaying plants and animals, upon thawing, permafrost releases carbon dioxide ... potentially launching humanity into an uncontrollable self-perpetuating disastrous warming phase.

As one might expect, most permafrost covers about 24% of the Northern Hemisphere and is found at high latitudes and altitudes, such as Siberia, Tibetan Plateau, Alaska, Greenland, Scandinavia, and Russia. It does not seem rational to me, but the Arctic is warming faster than the rest of the planet, at a rate that has not been seen in 2,000 years.

So, why does the permafrost release carbon when it thaws? As the plants/animals decay during thawing, CO2 and methane are emitted that were previously contained by the ice. If the protective layer of soil is saturated with water, the methane is 20 to 30 times greater than CO2. We don't know the exact proportion of Methane to CO2, but in the tundra (treeless plains overlying the permafrost) the average CO2 may be as high as 50 times more than methane.

The peat layers that have developed over the past 13,000 years seem to be protecting the permafrost. Wildfires can peel back the peat layer, exposing the permafrost making it more sensitive to climate change. Warmer temperatures bring more thunderstorms and lightening strikes. It appears we are seeing more of that happening recently.

For those that live on the permafrost, it is particularly disconcerting. As the permafrost melts, the ground become unstable. Those residents are dealing with buildings shifting and collapsing. Some towns have had to relocate entirely. In other instances, construction of roads have disturbed the permafrost to

a level that triggers exposure to warm temperatures causing the release of the gases. In turn, the CO2 and methane have killed off vegetation along the roadways. The roads are sinking and creating craters that make the roads unusable.

Other causes for concern are diseases, microbes, bacteria, and viruses that have survived in the permafrost are now raising their ugly heads. One article speaks of a young boy in 2016 contracting anthrax on the Yamal Peninsula in Siberia. Dozens more were hospitalized. All as the result of a carcass of reindeer that had died of anthrax 75 years ago. It became exposed during permafrost thawing.

I have a friend that lives in Wyoming, her in-laws have a large cattle ranch through which the Oregon Trail wanders. Many years ago, they dug a foundation for a barn and discovered the remains of a family that had died of smallpox along the trail. My friend's family had to quarantine for a very long time while the experts took care of the issue. All because the smallpox virus survived!

The mere challenge of building roads on permafrost is reason enough to not do it! Often unseen are 'ice wedges'. These are slivers of pure ice wedged in the ground. Sometimes 80 feet deep. They are covered by silt and impossible to see from above. 'Ice lenses' lay vertically just below the surface. Both make it difficult to build a stable road.

While we contemplate the damage to property and risk to human life from increased number and strength of storms, size, and frequency of wildfires, this is another reason why we should be considering our carbon footprint. I am not an expert and cannot say with any credibility that the carbon problem is caused by humans, I can say with confidence there are things we can do to lessen the impact.

SEEING IS BELIEVING: CORCORAN HIGH SCHOOL & PRE-APPRENTICESHIP

On January 17, 2019, Empire State Development (ESD) awarded MACNY a \$200,000 grant to launch a "preapprenticeship" program for Manufacturing Technology students at Corcoran High School.

This June, we celebrated the first seniors graduating from the program.

To note the occasion, State Assemblymember, William Magnarelli, grant sponsor, dropped in for "Show & Tell" at Corcoran in May. As ESD underwrote the design and development of this program in the heart of his district, Magnarelli was eager to witness its results for himself.

The motivating idea was to prepare students, starting in ninth grade, for careers in advanced manufacturing, ideally through Registered Apprenticeship programs. A Steering Committee comprised of Syracuse City School District administrators and instructors, local employers, and MACNY Workforce Development Specialists, met regularly to design and successfully execute the program, despite setbacks precipitated by COVID-19 in 2020.

The first stop on Assemblymember Magnarelli's tour was the welding lab. While welding wasn't included in the initial design of the program, the Steering Committee added it in 2021. This action provided students with the same opportunities as the Manufacturing Technology cohorts for work-based learning opportunities with local employers, including those offering Registered Apprenticeships.

If you haven't had the chance to visit the Corcoran Welding lab, you're missing a hidden gem. Gleaming Lincoln Electric equipment fills the room. Welding instructor, Jose Ocasio, has set it up with his students' careers in mind; this is a spotless, organized, professional environment. Assemblymember Magnarelli witnessed students completing senior projects per Ocasio's specifications in an atmosphere that was loud and

busy, sparks flying behind safety shields, precisely what one would experience on the shop floor at Morse Manufacturing, CNY Fabrication, or JPW Structural, all employer partners in this program.

The Manufacturing Technology classroom buzzed with students assembling furniture and creating "I Love Manufacturing" pins for their guests. Instructor Tequila Gregory pointed to new training equipment, including a tabletop CNC Machine, tool kits for each student provided by this grant, and the ways in which her students were putting them to use. Assemblymember Magnarelli was impressed by the scene and took the opportunity to chat with the students, proud of their accomplishments. We all marveled at the way the program has come together since 2019.

Going forward, the welding program is experiencing oversubscription, creating a waiting list. Manufacturing Technology juniors and seniors will attend Onondaga Community College next year to gain dual enrollment credits. The Steering Committee worked to align these courses with the Industrial Manufacturing Technician apprenticeship trade outline. The goal is for these students to jump-start their associate degree or Registered Apprenticeship (or both!) with college credits. If you're familiar with P-TECH, you will recognize that these programs follow a similar structure.

Assemblymember Magnarelli praised the students, their instructors, the SCSD administrators, and MACNY for the careful, considerate use of these funds and for setting up the "pre-apprenticeship" program for sustainability. What he didn't observe was the participation of our Syracuse-area manufacturers who have donated their time and energies as career coaches, job shadow hosts, and internship coordinators for these students, employer partners for years to come. Special thanks to those employers who provided the external review team that helped SCSD to attain NYSED certification of the Manufacturing Technology program in 2021 - 110 Metalworks, Anoplate, CNY Fabrication, and Westrock – without whom this program would not have reached these heights.
